Thank you for your service to the students, parents, and staff of the Kenai Peninsula.



Dear Mr. Peterson,

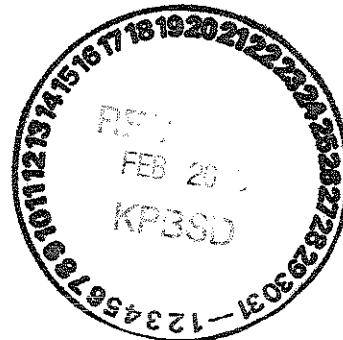
