**APPROVAL OF AGENDA:***(7:01:58 PM)*

The agenda was approved as written.

**APPROVAL OF MINUTES:***(7:02:15 PM)*

The School Board Minutes of October 14, 2013 were approved as printed.

**SCHOOL REPORT:***(7:02:35 PM)*

Mr. John Pothast, Redoubt Elementary Principal, introduced Mrs. Tara Oberts and two groups of pre-kindergarten students. The first group sang "Peanut Butter" by Dr. Jean Feldman. The second group sang "My Mother is a Baker" also by Dr. Jean Feldman. Mr. Pothast then presented a computer presentation highlighting the school's band and Spanish programs, after-school intramurals, Boys and Girls after school program, art, Positive Behavior Interventions and Supports (P.B.I.S.) and the related improvements in student discipline, and "Roadrunner" award cards. To complete the presentation, he shared the poem "Compassion" by Kevan Meyers.

At 7:24 p.m., Mr. Arness called a recess.

At 7:30 p.m. the Board reconvened in regular session.

**PUBLIC PRESENTATIONS:***(7:30:35 PM)*

Mr. Thomas R. Daly, owner of HiSpeed Gear, spoke regarding the District's technology plan and his concerns over District bid requests that specify a manufacturer.

Ms. Andrea Eggleston, Soldotna Middle School teacher, spoke regarding Soldotna Middle School's color and mascot and asked the Board to allow them to remain unchanged.

Mr. Austin Laber, Skyview High School student, read a letter from the school's student council regarding the Soldotna school's reconfiguration, especially the high school colors, name, and mascot.

Mr. Rob Lewis spoke regarding his concerns over the cost involved if changes are made to school names, colors, and mascots due to the Soldotna area school's reconfiguration; the need for the cost to be made public before final decisions are made; and he encouraged the Board to leave these three items as they currently are at each site.

**COMMUNICATIONS AND PETITIONS:**

Dr. Atwater announced that in a recent private ceremony, the District revised a Golden Apple Award presented to Mr. Joe Kashi in February 2010, to include his wife, Mrs. Terese Kashi, (as she was equally involved in the endeavors for which the award was given) and thanked them both for their service to the District. He reported the FY15 budget is not yet complete but will be available at the November 12, Budget Committee meeting. He discussed the District discipline data report in this month's general information packet. He noted that an Alaska Communications television commercial filmed last summer and featuring the District, is now airing and shows the District well. He thanked Ms. Pegge Erkeneff and Soldotna Middle School for their work on this project.

**ADVISORY COMMITTEE, SITE COUNCIL AND/OR P.T.A., K.P.A.A., K.P.E.A., K.P.E.S.A, BOROUGH ASSEMBLY:**

Mr. Neil Denny, K.P.E.A president, stated that he and Mrs. Patty Sirois, K.P.E.S.A. president, are continuing to visit schools. He discussed a meeting that he and Mrs. Sirois attended with Mr. Doug Hayman and Ms. Joann Riener regarding the staffing of the Soldotna area schools after the reconfiguration and emphasized the need to remain positive when dealing with student and staff issues.

Mrs. Maya Moriarty, on behalf of herself and Mrs. Mica Van Buskirk, Seward Site Council President, spoke in favor of the reconfiguration of Seward schools to move the 6<sup>th</sup> grade students to the middle school.

**SUPERINTENDENT'S REPORT:**

*(7:52:43 PM)*

Dr. Atwater reported that the 20 day count period for student enrollment ended on October 25, District enrollment is under projection by 162 students (52 of which are Connections Homeschool students) and this reduction will result in the District receiving less funding than budgeted. (Note: Dr. Atwater reported later in the meeting that the 162 student figure is incorrect and that he will provide the Board with the correct figure at their November 5, 2013 worksession.) He stated that work continues on the Soldotna area schools reconfiguration, including the plans for staffing. He thanked Mr. Neil Denny-K.P.E.A., and Mrs. Patty Sirois-K.P.E.S.A., for their collaborative work with Ms. Joann Riener and Mr. Doug Hayman. He reported that there are three early entrance kindergarten students for this year. He stated that the second of the scheduled early release dates went well and thanked the Board for approving these days. He congratulated the Nikiski High and Soldotna High football teams for each winning their respective state championships and Miss Allie Ostrander, Kenai Central High student, for her state cross-country running championship.

Mr. Holt reported that he attended a Skyview High School Site Council meeting where they discussed the reconfiguration, the philosophy of the staff to know every student in the school, and stated that he hopes that this attitude will carry forward to the new, combined high school.

Mrs. Vadla reported that she attended the final Soldotna Area Schools Advisory Committee meeting on October 21, thanked Mr. Doug Hayman and the committee for their work, and stated that she is confident that the Soldotna students will handle the changes well. She reported that she visited Soldotna area schools on Halloween and All Saints Day and plans to visit Skyview in the upcoming week.

Ms. Hohl reported that on October 24, 2013, she attended the Seward Public Hearing regarding the reconfiguration of Seward schools.

Mr. Arness reported that on October 24, 2013, he also attended the Seward Public Hearing regarding the reconfiguration of Seward schools.

Mr. Arness reported that the Board held worksessions regarding Board Policy, Capital Projects and Major Maintenance, Seward Elementary and Middle Schools Reconfiguration, New School Construction Process, and Soldotna Advisory Committee Report. She stated that she attended an Alaska Behavior Health Association Board training as a Seaview Community Services Board representative. She expressed appreciation for the various committees and agencies that all work together for the good of Alaskan communities.

She thanked the Seward area residents and the Skyview High School representatives for their comments. She thanked Redoubt Elementary for their presentation. She thanked Soldotna Middle School staff for their comments and input. She thanked Mr. Doug Hayman for his work with the Soldotna Area Schools Advisory Committee. She thanked Mr. Arness for his comments during a worksession earlier in the day.

Mrs. Hilts thanked the Board for the flowers given to celebrate her election as this year’s A.A.S.B. president. She expressed appreciation for the District, the Board, and the emphasis placed on, and aid given to, District students in transition. She expressed appreciation that the evening’s discussions focused on students and children.

Mr. Arness stated that Ms. Hohl represented her opinion and that it is unfortunate she has been ridiculed for it. He asked that the community respect the opinions of the Board members, and endeavor to understand that the Board’s goal is to make the best decisions possible for all concerned.
