SCHOOL REPORT:
(7:02:12 PM)

Ms. Mo Sanders, Soldotna Montessori Charter School principal, greeted Board member Mr. Castimore. She discussed the school's location, population, demographics, assessment scores, and current Alaska School Performance Indicator star rating. She stated that students are actively involved in multiple community service programs around the city. She introduced five students, (Mr. Seth Payment, Miss Adrienne Seaman, Mr. Ayden See, Miss Zoey Zurfluh, and Miss Katelynn Best) who each reported on his or her community service location including the Riverside House, the Soldotna Senior Center, and the Kenai Peninsula Food Bank. Ms. Sanders explained the foundations of the Montessori program. She reported on the school's annual trip to the Model United Nations Conference in New York City, the fundraising required, and the opportunities afforded through the experience. Ms. Sanders introduced two students, Miss MaCady Musgrave and Mr. Peyton Story, who discussed this year's upcoming trip.

Ms. Sherry Hingley, Sterling Elementary principal, presented a PowerPoint highlighting the school's location, demographics, staffing, academic programs, band, forensics, and Battle of the Books. She introduced district forensic competitors, Miss Morgan Burlingame, who performed the poem, "And My Heart Soars" by Chief Dan George, and Miss Kimberly Trefon who performed the story "Seven Foolish Fishermen." Ms. Hingley reported on the school's Positive Behavior Intervention and Support (P.B.I.S.) program and its importance at Sterling Elementary. She introduced teacher and P.B.I.S. coordinator, Mr. Donny Joachim, who further explained the program's three focuses (being respectful, responsible, and safe) and showed a school created bus safety video demonstrating P.B.I.S. philosophies. In closing, Ms. Hingley discussed school attendance and intervention processes.

On behalf of Dr. Atwater, Mr. Dusek reported that the District is working with the Matanuska-Susitna School District to share resources and practices for establishing the criteria for student learning objectives; i.e. student learning data as it applies to teacher evaluation. He stated that interviews were held for the Susan B. English School principal position, audience input was due today, and district office administrators will meet on Wednesday, March 5, to make a decision. He reported that the District is currently seeking survey input regarding this year's early release days and a summary of the results will be available in April to help determine whether or not to continue this practice. He congratulated the special education staff of Homer High School on being presented with the state's Inclusive Practices Award in February. He congratulated Kenai Central High School teacher, Greg Zorbas, on being honored as the Alaska Society of Technology in Education (A.S.T.I.) teacher of the year for his work in helping develop the district's "Classroom without Walls" program. He noted that the district-wide forensics competition was held at Tustumena Elementary on Saturday, March 1, stated that the full results will soon be posted online, and commented on the excellence of the performances.
