Students

EXCLUSIONS FROM ATTENDANCE

The School Board recognizes that there may be cases where denying admission is necessary because a student's presence in school presents a danger to the life, safety or health of students or school personnel.

The Board may exclude students from school because of a physical or mental condition which will render the student unable to reasonably benefit from the programs available or which will cause the attendance of the student to be harmful to the welfare of other students.

Students and their parents/guardians will be afforded due process rights to which they are entitled by law, board policy or administrative regulations.

BP 5112.2 Exclusions from Attendance and BP 5142.22 Infectious Diseases

"With regards to denying admission 4AAC06.060(b) states this is a board decision. The term "exclude" is not used in the statutes, only expulsion, suspension, and denial of admission are used. BP 5142.22 is adequate to support the superintendent temporarily excluding a student due to an infectious disease. However, if a student were going to be permanently denied admission because of an infectious disease it would need to be elevated to the board. I would leave 5112.2 as is.

As 14.30.047 provides for child who has been suspended or denied admittance to be permitted to attend school when the child is obviously recovered <u>or</u> presents to the governing body a statement in writing from a medical authority that the student is no longer afflicted. Since the word "or" is used where the student is being temporarily excluded from school because of an infectious disease it is within the superintendent's purview to exclude and readmit, where the exclusion from school is permanent due to a board action would be required. "

Students

INFECTIOUS DISEASES

The School Board recognizes its dual responsibility to protect the health of students from risks posed by infectious diseases and to uphold the right of students to a free and appropriate education. The District requires all staff to routinely observe Universal Precautions to prevent exposure to blood borne pathogens.

The admission or continued attendance of a student with an infectious disease shall be determined by the Superintendent in accordance with current medical and educational standards. The Superintendent shall consult with the student's parent/guardian and/or other appropriate medical and state health personnel as necessary when making this determination.

Students with Blood Borne Pathogen Infections

The Board recognizes that HIV and Hepatitis B Virus and Hepatitis C Virus are blood borne pathogens and not casually transmitted. A student with a blood borne pathogen infection is entitled to the rights and services accorded to other students. The sole presence of blood borne infection is not sufficient reason to exclude a student from attending school.

The District recognizes that there are persons infected with blood borne pathogens who are as yet undiagnosed and, therefore, unaware of their condition. The District also recognizes that the use of Universal Precautions minimizes blood borne pathogen exposure. Therefore, the District requires all staff to use Universal Precautions when caring for any ill or injured student or coworker or when performing tasks (i.e., diaper changes) that could include contact with body fluids.

Parents/guardians whose child has been diagnosed with a blood borne pathogen infection are encouraged to inform the Superintendent. Upon receipt of this information the Superintendent shall convene a 504 Accommodation Team. After receiving a signed parent release form, this team shall request medical and other information needed to conduct a review of the student's educational and health needs, as well as the school's capacity to meet these needs. The team will make written recommendations regarding appropriate programs and services for the student. This documentation will be housed with the Superintendent.

The Superintendent shall ensure that all of the student's rights to confidentiality are strictly observed in accordance with law.

AR 5141.22 Infectious Diseases

4 AAC 06.060. Suspension or denial of admission

(a) In a public school, the superintendent or principal may suspend a pupil under the provisions of AS 14.30.045, and the pupil may be reinstated by the superintendent or principal or by the school board. A child who is diagnosed as having acquired immune deficiency syndrome (AIDS) or the human immunodeficiency virus (HIV) does not have a condition which "will cause the attendance of the child to be inimical of the welfare of other pupils," within the meaning of AS 14.30.045 (4), unless the child has uncoverable oozing lesions or other symptoms, or displays behavior, such as biting, which in the opinion of a team made up of the child's physician, public health personnel, the child's parent or guardian, and school personnel associated with the child's educational placement, substantially increases the risk of transmission of HIV to other pupils.

- (b) Expulsion or denial of admission of a pupil shall be only upon the action of the governing school board in a district school.
- (c) A pupil suspended or expelled under this section may appeal to the district board.

TRANSPORTATION

The School Board desires to provide transportation for eligible students in accordance with state and federal law.

KPBSD shall provide transportation services to students attending KPBSD charter schools on a space available basis along the regular routes that the students attending schools in an attendance area in the district are currently being transported. If a charter school declines pupil transportation services, no funding allocation will be made by the District.

The goals of the transportation service are:

- 1. To provide maximum safety for students while being transported between home and school and on school-sponsored trips.
- 2. To promote desirable student behavior and respect for traffic safety.
- 3. To provide assistance and transportation for handicapped students.
- 4. To provide transportation for field trips.
