B. REPORTS

1. Dave Jones, Plan Administrator.

- Dave provided a worksheet for the traditional plan and the HDHP through June 30th, 2017. Traditional Plan EE was -\$137,805.48 deficit and the HDHP EE had an excess of \$93,071.80 so the total EE deficit with both plans was -\$44,733.67, the biggest paid out this year.
- Discussion on the rising health care costs and we need to focus on WHY?
- Dave is also working on a Welcome/Educational Video to include information on Teladoc and inform employees that the Health Plan is tied to the physical year and our PPO is AK Regional.
- Discussed health rates for this year (why only 3% not 8% as other years).

2. Stacey Cockroft, Benefits Manager.

- Stacey stated that Colleen couldn't make the September meeting so Stephanie motioned to cancel that meeting and Bruce seconded it with unanimous vote.
- Health Fair October 21st. Informed new system this year where you have to pre-register for a specific time slot. Email with instructions was sent to all staff on 8/22/2017.

3. Liz Hayes, Director of Finance

- Provided a spreadsheet through June 30 as a draft only until auditors review it.
- Caremark has not been split between Traditional and HDHP yet.

4. Colleen Savoie, Parker-Smith-Feek Consultant

- Update on AETNA PPO Discount report per REHN information 1/4 data in (expect a 20-22% discount for future depending where claims come from). 7/15-6/16 18% savings, Q1 19% savings, Q2 22% savings.
- Colleen was asked to get information to us at the next meeting on what % goes thru CPH,
 SPH, ARH.
- Provided a Utilization Report on the usage of Teladoc and a discussion ensued on how to get
 the information out to employees to utilize this service. Positive feedback for the most part
 on users.
