Concurrent with performing duties as the Elementary Principal was an additional responsibility for yearly application to and monthly reporting for Alaska's Child Nutrition Services. Established Annette Islands School District as a Provision Three school district due to the high poverty rate of the Metlakatla Indian Reservation. As a result, reimbursements from CNS generates in excess of \$100,000 annually.
