The Board presented Golden Apple awards to Tamara Johns, Soldotna High School volunteer and Dan Kaasa, Assistive Technology Specialist, for their service to the District.

Mr. Navarre read a memorial statement written for Takoda Zimmerman, student, written by the staff at the Nikiski North Star School.

Mr. John Pothast, Redoubt Elementary School principal, introduced prekindergarten students, who sang a song and played accompanying percussion instruments, directed by Ms. Tara Rosin, teacher. Mr. Jeff Moore directed the sixth grade band students in a song titled, *Dueling Dragons*. Mr. Pothast gave a PowerPoint presentation highlighting the Spanish program, Soldotna High School mentor program, school goals, use of SmartBoards, and the Book Club/News Club, and ended his presentation with a poem titled, *Famous*, by Naomi Shihab Nye.

Dr. Atwater announced that Financial Aide Night will be held on November 2 at the Soldotna Sports Center, the Budget Development Committee meeting will be held on November 10 in the Borough Administration Building, and the Administrator Meeting will be held on November 17 at the Challenger Learning Center. He noted that the Communications Report was included in the Board General Information packet. He reported that two Nanwalek students are participating in the Voyage to Excellence Program which is being held in Anchorage and paid for by funds from the Chugachmiut Regional Native Corporation.

She announced that the State School Board meeting will be held December 2 in Anchorage and that the proposed changes to teacher certification (4AAC12.405(a)) will likely be on the agenda for final review. She explained the reasons why the proposed changes will be detrimental to teachers who want to take professional development courses or cross-curricular courses and encouraged Board members to provide comment to the state board.

Mrs. Warner, KPESA president, reported that school visits continue and that she is receiving positive feedback from staff. She reminded those present to vote on November 2. She reported that she attended the NEA-Alaska Fall Event and that she assisted with the Train the Treasurer's training. She reported that she attended the statewide budget committee meeting and will attend the NEA-Alaska Board of Directors for Region III.

Dr. Atwater reported that Student Nutrition meetings were held in Homer, Kenai, and Seward and thanked Mr. Jones and Mr. Hamburg for their work and to those who attended. He reported that the college fair was held on October 22 at Kenai Central High with the participation of over 400 students and 48 college recruiters. He reported that the Borough Honor Choir clinic and concert was hosted by Soldotna High School and praised the students and music teachers. He expressed condolences to teachers Troy and Linda Zimmerman for the loss of their son, Takoda.

Mr. Sean Dusek presented the 2010-2011 Class Size Enrollment Report that included the number of sections for each school, a class size comparison by year, a comparison of pupil-teacher ratios and an average annual class size for core classes.

Mrs. Crawford reported that she attended the Policy Review Committee meeting and noted that several policies were reviewed which will be brought to the Board. She reported that she represented the School Board by serving on the Teacher of the Year Selection Committee and that the announcement will be made at the AASB Annual Conference.

Mrs. Vadla reported that she attended the Communication Committee meeting, that the group reviewed communication documents to date, discussed the District's membership in National Public School Relations Association and participation in the communications survey, and internal and external communication goals. She reported that she attended a presentation by the Forestry Service that encourages teachers to use the national historic Iditarod trail to create collaborative learning opportunities throughout the state. She attended the Seward PTSA meeting.

Mrs. Downing reported that she attended the nutrition meeting in Homer and noted that a group from Paul Banks Elementary has been working on promoting good student nutrition. She hopes to see a rejuvenation of the Wellness Committee. She commended Mr. Hamburg and Ms. Buchanan for doing an outstanding job on the Student Nutrition Services presentation to the group.

Mrs. Vadla thanked the administration for the worksession information and discussion including the curriculum audit update, the class size information, and the vocational curriculum. She thanked Ms. Andrena Stone, attorney for Jermain, Dunnagan and Owens, for the student drug testing information. She thanked Mr. Pothast for the Redoubt Elementary School report.

Mrs. Crawford expressed appreciation for the Redoubt Elementary School presentation. She thanked Mr. Dusek for the class size report. She stated that she is pleased with the direction of the Board regarding the curriculum audit. She requested an excused absence for the December 6 meeting.

Ms. Hohl expressed appreciation for the Redoubt Elementary School report. She thanked Dr. Atwater for the litigation status report. She reported that she briefly observed a classroom without walls, held at the Kenai Convention and Visitors Center and taught by a Russian teacher and a history teacher linked live with two other District schools. She reported that she attended the Seward Halloween Carnival, sponsored by the Seward Seahawk Athletic Boosters and the Seward Parks and Recreation Department.

Mrs. Downing stated that she was impressed by the good work by the District administration in schools and communities to support students. She reminded those present to vote.

Mr. Navarre encouraged those present to vote on November 2. He requested an excused absence for December 6. He encouraged those present to visit the Challenger Learning Center's new addition of an interactive globe called the magic planet.

Mrs. Hilts thanked the students and staff for the Redoubt Elementary School report and for collaboration with Soldotna Middle School. She stated that she was struck by the enormity of the curriculum audit implementation process. She stated that implementation will take a lot of effort, a lot of dedication and commitment, more personnel, and that it will be a long-term job.

Miss Rang reported that she participated in the 2010 regional swimming and diving championships and noted that the girl's teams placed: second for Homer High, fourth for Kenai Central High, sixth for Seward High School and seventh for Soldotna High School. She announced that the boy's teams placed: second for Homer High, third for Seward High School, fourth for Soldotna High School, fifth for Kenai Central High. She congratulated Winter Heaven, Kenai Central High, for breaking four regional records.

Mr. Arness asked about 20-day count, specifically Cooper Landing Elementary. Mr. Jones reported that Cooper Landing made it through the count period with 10 students. Mr. Jones added that overall the District enrollment came in a little under the projection and that the intensive needs students count was higher than expected and that further information will be available in December.
