Without a drastic increase to the BSA, this change would leave the district with no choice but to reduce staffing. The intent of this resolution is good-we all want teachers to have a defined benefit. Unfortunately, the reality of making such a change is not financially doable. Recommendation that Board suggest an amendment to include language that would hold the district contribution at 12.5%.
