SUBJECT: Budget Transfers

Budget transfer 140 in the amount of \$11,484 has been requested by the Kaleidoscope Charter School to pay for additional benefits for currently hired employees.

Budget transfer 174 has been requested by the Pupil Services Department to move funds budgeted for summer school into salary and benefit categories that reflect the actual employees hired to provide summer school to students, namely \$29,713 for aide salaries. The administration has given preliminary approval to this transfer, pending review and approval by the board.

A budget is a financial plan used to estimate costs to deliver services in accordance with the District's Strategic Plan. It is sometimes necessary to make changes to the original plan, based on unexpected circumstances or changing program needs, through the use of budget transfers in accordance with Generally Accepted Accounting Principles (GAAP). Policies and procedures in conjunction with the District's internal control procedures have been established to facilitate all budget transfers.

These budget transfers exceed \$10,000; therefore, they require Board of Education approval per Board Policy 3120. Approval by the Board of Education is recommended.
