SUBJECT: Budget Transfers

Budget transfers 175 and 176 in the amounts of \$5,650 and \$5,394, respectively, have been requested to purchase components for replacement sound systems for the Seward High School and Homer High School Auditoriums to facilitate Board of Education meetings held in Seward and Homer.

These budget transfers have already been approved and since they do not exceed \$10,000, they are exempt from the requirement for Board of Education approval outlined in Board Policy 3120.
