<u>Title 1 2022-2023</u>: The staff and I have been working on a needs assessment to expand our focus of Title 1 services from K-2 to K-4. Our estimated funding for FY23 will provide a half-time interventionist with focus on early literacy. Over the past five years, I have communicated the importance of families to complete the Free and Reduced lunch application whether their child eats a hot lunch at school. The percentage of families that qualify for free and reduced lunches provides the school with Title 1 funds.
