

# HOPE SCHOOL PTO PROPOSAL: GRADUATING SENIOR SCHOLARSHIP FUND

## Purpose

This proposal is for the creation of an annual **Hope School PTO Graduating Senior Scholarship**: to recognize and support exceptional students who embody the heart of our school and community. This scholarship will assist students as they pursue their next step in education or training, reflecting the PTO's mission to celebrate achievement, encourage lifelong learning, and strengthen the Hope community.

## Scholarship Overview

- **Name:** Hope School PTO Graduating Senior Scholarship
  - **Award Amount:** \$2,500 per recipient, applied directly toward tuition
  - **Number of Recipients:** To be determined annually based on available funds
- 

## Eligibility Criteria

Applicants must:

- Be graduating seniors of **Hope School (KPBSD)**.
  - Have a **minimum cumulative GPA of 3.0**.
  - Plan to **continue their education through college, trade school, apprenticeship, or other recognized post-secondary or leadership development program** beginning in the next academic year following graduation.
  - Submit a **one-page typed essay** titled *"What My Hope School Education Has Meant to Me."*
  - Include **one letter of recommendation from a Hope School teacher and one letter of recommendation from a community member not related to the applicant**.

## Selection Process

A small selection committee appointed by the PTO—consisting of one parent, one teacher, and one community member—will review all applications. Selections will be based on academic achievement, personal character, community involvement, and the strength of the essay and recommendations.

## Funding and Administration

- Scholarship funds will be designated as a separate line item in the PTO budget for transparency.
- Awards may be paid directly to the recipient's post-secondary institution upon proof of enrollment or in reimbursement to the student upon receipt of enrollment costs.
- The PTO Board will review the program annually and confirm the number of scholarships and the amount of each award given each year.
