



## 2022 “VOTE BOLDLY” ELECTIONS ARTWORK CONTEST PARENTAL CONSENT FORM

By signing this Parental Consent Form:

1. I hereby agree that my minor child may participate in the Elections Artwork Contest hosted by the Alaska Division of Elections (“Division”), and irrevocably grant my permission and authorize the Division to use my minor child’s first name, school name, grade level, town, artwork and photograph in advertising, marketing, and promoting the contest, and to reproduce and publish the same throughout the universe in perpetuity, in any and all media now known or hereinafter devised. I further agree that the contest, my minor child’s participation in the contest and all of the contest elements belong entirely and exclusively to the Division, so that the Division and its licensees and assigns may duplicate, distribute, broadcast, exhibit, or otherwise use the contest without limitation or restriction throughout the universe in perpetuity. The Division may edit and adapt my child’s participation as it deems appropriate.
2. I understand my minor child’s first name, school name, grade, and town that I provide on behalf of or related to my minor child, as described in the Official Contest Rules, may be posted together with my minor child’s submission upon the Division’s website and social media platforms, as well as other public forums, such as the media, without any additional notice to or permission by me.
3. I understand and agree that neither I nor my minor child will own any rights in the contest or the contest elements, or receive any monetary compensation relating thereto. I am granting the Division a free, non-exclusive, irrevocable license to use my minor child’s first name, school name, grade level, town, artwork, and photograph to fulfill the purposes of the contest. I acknowledge that the Division shall have no obligation at all to use my minor child’s information in the contest.
4. I agree that neither I nor my minor child shall make any claims against the Division based upon distribution or exploitation of the material or the contest and its elements to which I have consented on behalf of my minor child. I release the Division and its licensees and assigns from any and all claims and liabilities whatsoever that may occur in relation to or arising from my minor child’s participation in the contest. I agree that this consent and release will be governed by and construed in accordance with the laws of Alaska.
5. I confirm that my minor child lives in the United States of America, State of Alaska, and is the required age noted in the Official Contest Rules.
6. I agree that my minor child may participate in the contest described in the Official Contest Rules.
7. I hereby warrant that I am a legal competent adult and a parent or legally appointed guardian of the minor child named below, and that I have every right to contract for the minor child in the above regard.
8. I certify and acknowledge that I have read, understood and agree to the Official Contest Rules, and that I have read this Parental Consent Form prior to signing it; that I have the full authority to give my consent and release so that my minor child may participate in the contest and that I consent to provide the information concerning my minor child that is necessary to enter the contest and if selected, to be awarded a finalist, runner-up, or winner.

Accordingly, and intending to be legally bound, I voluntarily agree to the terms set forth herein and acknowledge and agree that my minor child and myself are bound by the Official Contest Rules and I am bound by the terms of this Parental Consent Form. This release shall be binding upon minor child, me, and our respective heirs, legal representatives, and assigns.
