

SELDOVIA SEA OTTERS

BOOSTER CLUB BYLAWS

ARTICLE I - NAME

The name of this organization shall be the Seldovia Sea Otters Booster Club, hereinafter referred to as the Sea Otters Boosters.

ARTICLE II - OBJECTIVES

The objectives of the Sea Otters Boosters shall be:

Sec. 1. To arouse and maintain an enthusiastic interest in the various facets of co curricular activities of Susan B. English School.

Sec. 2. To lend all possible support, both moral and financial, to the co-curricular activities of Susan B. English School.

Sec. 3. To cooperate with the Susan B. English Administration to the end that this program be maintained at the highest possible degree of efficiency.

Sec 4. To offer a wide variety of support for the changing needs of the student body such as, but not limited to sports travel, academic travel, travel opportunities for SBE students which encompass academia, social emotional support and positive personal growth and/or through the Booster Club Support program. ARTICLE III - MEMBERSHIP.

Sec. 1. The membership of the Sea Otters Boosters shall be open to anyone interested in the progress and development of the co-curricular activities of Susan B. English School.

IV - OFFICERS

Sec. 1. The officers of this organization shall be a president, vice president, and

secretary/treasurer. Officers may also be organized as President/secretary, vice president and treasurer. .

Sec. 2. Any member shall be eligible to run for and serve as an officer and/or chairperson of any committee

Sec. 3. Terms of office for all officers shall be one year; serving September to September. (Amended 9/03)

Sec. 4. In the event that an officer cannot complete his/her full term for any reason, a replacement for that term will be appointed by majority vote of the remaining members.

ARTICLE V - DUTIES OF OFFICERS

Sec.

1.

The PRESIDENT shall preside at all meetings of the organization, appoint all committees, and shall be an ex officio member of all committees, except the nominating committee.

Sec. 2. The VICE PRESIDENT shall assume all the duties of the president in his/her absence. He/she shall serve as the chairperson of the membership and nominating committees and assume other duties as are deemed necessary.

The SECRETARY/TREASURER shall keep the records and minutes of all meetings, attend to the correspondence, receive all funds due the organization, fill out appropriate submission forms for reporting to Susan B. English Administration, and perform such other duties as deemed necessary.

ARTICLE VI - MEETINGS

Sec. 1. The regular meetings of the Sea Otters Booster Club shall be held on the first Thursday of each calendar month, except when changed by vote of the general membership.

Notice shall be given at least 24 hours in advance.

A Quorum shall consist of those members present

ARTICLE VII - ELECTIONS

Sec.

1.

Nominations may be made from the floor.

Sec. 2. Officers are to be elected at the regular September meeting. They shall take office at the regular October meeting.

A majority vote of the members present shall constitute an election.

ARTICLE VIII

Sec. 1 Accounting: Sea Otters Booster Club accounts are held in a KPBSD 710 account specific to Booster Club. Deposits are to be made through the SBE School Secretary. Expending funds from a KPBSD 710 account must follow the guidelines set by KPBSD for expending funds. (amended 2/2021)

ARTICLE IX - AMENDMENTS

These Bylaws may be amended by a 2/3 vote of those present at any regular meeting. The amendments must have been presented at the preceding regular meeting of the Sea Otters Booster Club.
