#### Overview

In support of strengthening student academic achievement KPBSD receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(b)(1) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. The policy establishes the district's expectations and objectives for meaningful parent and family involvement and describes how the district will implement a number of specific parent and family engagement activities.

The **KPBSD** agrees to implement the following requirements as outlined in Section 1116 of the ESEA, as amended:

- Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under Title I, Part A, including the planning, review, and improvement of the school parent and family engagement policy and the joint development of the schoolwide program plan under Section 1114(b)(2) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended. #### Joint Development

**Tebughna School** will take the following actions to involve parents and family members in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I, Part A programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

#### Annual Title I, Part A Meeting

**Tebughna School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I, Part A program, the nature of the Title I, Part A program, the parents' requirements, the school parent and family policy, the schoolwide plan, and the school-parent compact.

- We contacted parents to ask what time would be convenient for them to be able to attend our Annual Meeting.
- 2. We sponsored our Annual Meeting on September 4<sup>th</sup>, at 6:30 p.m., to allow for working parents to attend.
- 3. We had a great turnout of parents and children. After our discussion, we had ice cream in the cafeteria.

#### Communications

Tebughna School will take the following actions to provide parents of participating children the following:

- Timely information about Title I, Part A programs.
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parental involvement.
- A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards.
- If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.
- Information related to the school and parent and family member programs, meetings, and other

  including alternative formats upon request and, to the extent practicable, in a language the parents can

#### School-Parent Compact

**Tebughna School** will take the following actions to jointly develop with parents of participating children a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

- 1. If parents request for on-site students, or as students "become remote learners" (for various reasons such as illness or student/family quarantine), we send home packets of work for student practice.
- 2. We send home progress reports mid quarter (each quarter) so parents and students are aware of their achievement scores, and what they may need improvement in.
- 3. We regularly update our PowerSchool grades for students and parents can know weekly how their children are doing in class.
- 4. We have an "Open Door Policy" (now with COVID it is "Open Phone Call Policy", where parents can always call us to discuss a child's academic achievement.
- 5. We sponsor evening activities every two weeks so parents feel comfortable attending our school and having "open lines of communication" with all staff.

#### Reservation of Funds

The **KPBSD** will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental and family engagement is spent. (Only applicable to districts with an allocation of \$500,000 or more.)

- Funds reserved under this section by the district agency shall be used to carry out activities and strategies consistent with the district's parent and family engagement policy, including not less than 1 of the following:

Whatever activities we are planning, we include parents to assist in decision making. We send home texts, emails, make phone calls, Friday Focus, monthly newsletters, flyers on school website and Facebook page, flyers sent home with students, signs posted at school., and word of mouth.

#### Coordination

**Tebughna School** will coordinate and integrate parent and family engagement strategies under Title I, Part A with parent and family engagement strategies, to the extent feasible and appropriate, with other relevant Federal, State, and local laws and programs.

We work with Tebughna Foundation for cultural education, Project Grad for Social Emotional and cultural aspects, and Cook Inlet Tribal Council for our Innovation Station (Fab Lab) which assists in creativity, cultural pride, CTE experience. We further work with Tyonek Tribal Council Foundation for many of our science lesssons including learning about the life cycle of salmon (Alaska Fisheries Salmon Project) and our regular Tyonek garden and our hydroponics garden. We also have support from other programs and organizations which provide support and resources for our families. Many of our Title 1 activities through the year are coordinated based on the assistance and suggestions of these partnerships.

#### **Building Capacity of Parents and Family Members**

**Tebughna School** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student academic achievement through the following:

- Providing parents and family members with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the proficiency levels students are expected to meet.
- Providing parents and family members materials and training to help parents to work with their children
  to improve their children's achievement, such as literacy training and using technology (including
  education about the harms of copyright piracy), as appropriate, to foster parental involvement
- Providing assistance to parents of participating children, as appropriate, in understanding such topics as the following:
  - The challenging State academic standards.
  - o The State and local academic assessments.
  - The requirements of Title I, Part A.
  - How to monitor a child's progress.
  - How work with educators to improve the achievement of their children.

KPBSD offers us many online and "in person zoom" webinars and classes related to improving the academics and the well-being of our students. We also have computers available in our library that parents can use to access these resources.

#### **Building Capacity of School Staff**

**Tebughna School** will, with the assistance of its parents, educate its teachers, specialized instructional support personnel, principals, other school leaders, and other staff on how to reach out to, communicate, and work with parents as equal partners, in the value and utility of contributions of parents, and how to implement and coordinate parent programs and build ties between parents and schools.

We have webinars and online rescources readily availbable to parents, as equal partners. These webinars include how to access and use our curriculum, and more specifically: Capstone, Audible Books, IXL, Brainpop, Reflex Math, ALEKS, Lexia, Read Naturally Live, Discovery Ed, World Book, SLED Digital Pipeline, PebbleGo, Tumblebooks, Canvas and Google Classroom, Live Homework Help and elementary and teen resources.

**Tebughna School** will provide other reasonable support for parental involvement activities under Section 1116 as parents may request.

Tebughna School is totally open to parental involvement and welcomes ideas, suggestions and assistance at our twice monthly activities. Parents can also apply to be a volunteer at our school by following all necessary health precautions set forth by our village, and applying on KPBSD.org to be a Volunteer.
