❖ Kachemak Selo and Voznesenka Title 1:

Annie Robinson (Voz) and Elena Basargin (Selo) shared information on our Title 1 programs. Details of events and activities from previous years were discussed, along with asking attendees for input regarding future plans. Along with activities, ways to best communicate and best times for meetings and events was also discussed. Attendees shared that they appreciate using WhatsApp as the best communication tool. Fall preparation for winter and weddings were collectively determined to be very time consuming during this time of year, yet understanding that meetings need to take place and priorities to attend can be made. When it came to asking what parents would like to see, regarding what Title 1 provides students, one parent brought up Kiwi crates, which was echoed as a great resource by other parents. ***** Kenai Peninsula College:

Michelle Waclawski from KPC (Kenia Peninsula College) talked with attendees about programs offered through the college that are accessible in Voznesenka two evenings a week. She provided examples of what previous students have covered and accomplished over the years and what is expected to be available this year. It was stressed that there is no cost for these classes and are available at Voznesenka, the college in Homer, and through a distance delivered option. The Voznesenka option is available to all HOB community members who are at least 16 years old and not enrolled in school.
