- C. Pro-rated Stipends for Coaching Beyond Contract Dates Phil Leck Informational
- D. Student Requirements for Participation in Interscholastic Activities Phil Leck (First Reading)
 - 1. IV. Student Eligibility. Section B. Item 5
- a. Current Language: "Practice. Athletic participants must have ten separate days of practice in the same activity prior to the first day of competition unless a waiver has been granted because of participation in a continuous activity (ASAA, Article VII, Section 5). Students may <u>not</u> have practices waived for football, gymnastics, hockey, wrestling or cheerleading."
- b. Proposed Language: Required Practice. Athletic participants must have ten (10) separate days of physical practice in the same sport activity prior to the 1st day of competition. If a student is participating in another school sport with overlapping seasons, then he/she may have up to five practices waived (ASAA, Article 7, Section 7).
- E. Student Scholastic Eligibility for Participation (First Reading) (Current Language Enclosure)
 - 1. IV. Student Eligibility. Section C. Item 1. a. b.
- a. Current Language: "2.0 GPA checks will be done each mid-quarter and quarter end. Additionally, students must be passing all classes at this time. Semester grades will be used at the end of quarters two and four for both 2.0 GPA and failing grades. A schedule of eligibility check dates will be printed annually in the KPSAA High School Handbook."

- b. Students determined to be ineligible at the mid-quarter check will begin their ineligibility on the *first school day* following the grade check until the next eligibility check. Students may regain their eligibility after seven calendar days if they meet the 2.0 GPA and are passing all their classes within the next five school days. Otherwise, they remain ineligible until the next eligibility check.
 - c. Proposed Language: (Current Language Enclosure)
- **a.** All first semester freshmen are immediately eligible at the beginning of the school year. At the end of the 1st quarter, they must have a 2.0 GPA and passing all classes to remain eligible for the remainder of the semester.
- b. Second semester freshmen, all sophomores, all juniors, and all seniors must have an overall 2.0 GPA and passing all classes during the previous semester and end of first and third quarters. Students who do not meet the requirements may regain eligibility during the current semester by achieving and maintaining an overall 2.0 GPA with no F's at the end of the quarter or semester using the grades earned during the nine week grading period.
 c. There will be a grace period for eligibility at the culmination of each quarter to allow time to submit grade changes. The deadline for this grace period will be 5 school days after the Q1

 d. (current language c.) At the end of the quarter, eligibility determination will be made on the first Wednesday of the new quarter. For second semester, the eligibility determination will be

- G. Sports Season Practice Rules, Language Change Phil Leck (First Reading)
 - 1. VI. General Activities Policies for the KPBSD. Section E. Item 2. State Tournaments
- a. Current Language: "There will be no practice sessions during the school year after the state tournament."
- b. Proposed Language: Out-of-Season is any time other than during the established high school season in a particular sport. During this time coaches may practice up to six hours a week, with out-of-season games or scrimmages counting as one hour. (from ASAA)

The "out-of-season" participation policy is suspended from May 20 through August 31. This means a coach of a team can coach his/her players anytime, anywhere, during this time period. During this time period the coach or other personnel representing the school is prohibited from requiring any athlete to participate as a condition of selection for the inseason team. (from ASAA)

- b. (2.) A fee of \$100 per activity shall be charged for cheerleading, Esports (per season), and performance dance.

- c. (5.) The maximum participation fee assessed any family will not exceed \$500 per year at the high school level only.
- d. Proposed Language: (1.) KPBSD has instituted an activity fee for all ASAA activities. The established fee for all High School activities is \$200, with the exception of cheerleading, Esports, and performance dance, where the activity fee will be \$100 per season.
- e. (2.) The maximum participation fee assessed any family will not exceed \$700 per year at the high school level only.
