Dr. Atwater announced that two District students, Alder Fletcher and John Hannan have been invited to apply for the Presidential Scholars' competition. He reported that the arsenic remediation activity has ended at Sterling Elementary. He reported that the school improvement plan for Title I schools has been approved by the Department of Education and Early Development and thanked Mrs. Miller for her coordination in that effort. He reported that principal hiring continues and that interviews for the Spring Creek principal/teacher will be February 8, Mt. View Elementary principal interviews will be in the afternoon on February 8, Soldotna Middle principal interviews will be February 10 and Soldotna Elementary principal interviews on February 11. He reported that February 7 through 11 is Alaska School Counselor week, and that February is School Board recognition month in Alaska.

Mrs. Warner, KPESA president, reported that she recently attended the NEA-Alaska Delegate Assembly and noted that four discussion items advanced to Priority One: restore defined benefit system, rural teacher housing, PERS employees to be allowed to apply accumulated sick leave towards years of service for retirement, and adequate funding for education. She reported that the Political Action Committee for Education (PACE) will be sending members to Juneau throughout the legislative session. She reported that she will travel to Washington D.C. February 23 through 27 to attend the National Resolutions Committee meeting. She announced that during the Delegate Assembly, Mr. Julian Polushkin, a KPBSD student, was selected as NEA-Alaska Student of the Year.

Mrs. LaDawn Druce, KPEA president, asked the Board to continue to look at funding for elementary school counselors Districtwide. She announced that BP Teachers of Excellence nominations are due February 14 and Read Across America is March 2. She asked the Board to consider reading at a District school on that date. She reported that she traveled to Philadelphia to participate in NEA's Northeast Regional Training and present a conference on advancing leadership skills. She traveled to Juneau as a representative for PACE and visited with KPBSD legislators. She traveled to the NEA-Alaska Delegate Assembly and noted that three new business items were recommended; support SB3, increase to food services for lunch and breakfast programs; TRS 3 and PERS 4 pension information; and research and develop model teacher evaluation procedures. She reported that two new legislative bills propose an increase to the base student allocation and hopes that it is funded for two or three years into the future. She suggested that with a \$100 increase in the base student allocation combined with the reinstatement of the grocery sales tax, the District would have approximately \$4 million. She reported that she will ask Assembly Member Murphy to join her during school visits so she can see where the money is being spent. She encouraged the Board to visit District schools in order to see that, contrary to public beliefs, schools are not failing.

**SUPERINTENDENT'S
REPORT:**

Dr. Atwater reported that the calendar for Russian Old Believer schools has been set. He noted that the list of administrator contracts for approval includes Vaughn Dosko as the principal for Kenai Middle School, Christine Ermold to serve as administrative oversight for Cooper Landing Elementary in addition to her duties as Sterling Elementary principal and Jason Bickling to provide administrative oversight for Moose Pass School in addition to his duties as Seward Middle School principal. He announced that the student leadership group is in Juneau participating in the Close-Up Program and will also meet with the governor. He announced that he will attend the American Association of School Administrators Annual Conference in Denver February 17 through 19. Dr. Atwater reported that the Kenai Central High gymnasium can be used beginning February 10 and did not require major repairs to damage caused from flooding in December. He added that more serious work to the floor will take place during the summer.

She stated that Mr. Dave Henson presented the National Schools Public Relations Association community accountability program survey timeline and that Dr. Atwater will revise the document. She reported that she attended a percussion presentation by students at Paul Banks Elementary who were studying from an Artist-in-Residence, Mr. Eddie Wood. She reported that she attended the AASB Legislative Fly-in and noted that there were some great presentations on technology and education. She noted that the Kenai delegation held discussions with other Board members throughout the state, met with over 30 legislators and met with Governor Parnell at the governor's mansion.

Mrs. Vadla reported that she attended the Soldotna High School Site Based Council meeting on January 11. She reported that she attended the AASB Legislative Fly-in in Juneau and was impressed with the presentation by Jason Ohler on the digital community and the digital citizen.

Ms. Hohl reported that she attended the Seward PTSA meeting, the Seward Schools Site Based Council meeting, the Quality Schools/Quality Students meeting in Juneau and the AASB Legislative Fly-in. She reported that Julie Lindquist, Seward High School parent, and Marilyn Johnson, Tebughna Elementary/High School principal, also attended the QS2 meeting. She reported that through the use of QS2 money, two projects have been accomplished in Seward and the community is looking at starting a school radio station.

Miss Rang reported that she attended the Youth Advocacy Institute as well as the AASB Legislative Fly-in. She reported that, while in Juneau, she had the opportunity to be a guest page. She stated that the meetings with legislators were very positive.

Ms. Hohl reported that she has attended two principal evaluation committee meetings and provided the Board with a rough draft copy of the framework of practice that goes along with the teachers' framework. She stated that the committee would like input from the Board and asked that ideas and comments be sent to her or Mr. Dusek.

Mr. Navarre reported that he attended the Kenai Middle School Site Based Council meeting and noted that the superintendent spoke to the group about the principal replacement process. He reported that he attended the AASB Fly-In in Juneau and noted that the Hope community has a new legislator, Senator Kathy Giesell.
