Mrs. Sheila Margaret Pothast's Spanish students provided Mexican hot chocolate to the Board members and administration. Mr. Sargeant Truesdell, Soldotna Middle School principal, thanked the school's exploratory teachers for creating the slideshow. He provided school demographic information, staffing information, described the exploratory courses and the partnership with Redoubt Elementary School. He provided a video clip highlighting exploratory courses in art, shop, Spanish, technology, and music.

Mr. Todd Syverson, Soldotna High School principal, introduced Miss Meggean Bos, Family and Consumer Science teacher, who showcased the six classes offered under the Family and Consumer Science program with the help of three students. Miss Megan English explained the lessons learned in the Interior Design class. Miss Bos noted that the Culinary Arts students made the snickerdoodle cookies that were shared with the Board and administration. Miss Morgan Lancaster explained the lessons learned in the Interpersonal Relationships class. Mr. Henry Anderson, retired teacher and KPEA past president, expressed concern for the direction of negotiations (i.e. regressive salary and working conditions). He explained the need for agency fees and asked the Board to direct the bargaining team to retain the fees section of the negotiated agreement.

Ms. Brett Glidden, McNeil Canyon Elementary parent and Site Council member, spoke against the proposed change in bus service for the Homer area. She suggested the District create an ad hoc committee to thoroughly review and solve the funding problem of student transportation. She suggested that the District urge the state to restructure the reimbursement procedure from a per student basis to a per diem basis. She provided information from and a copy of a report titled, *Cost-Effectiveness in Pupil Transportation: A Comparison of In-House and Contracted Services*.

Ms. Marge Hays explained that she would read a statement written by her husband, Hugh Hayes, who was unable to attend. Mr. Hays is a former teacher and expressed support for union representation fees.

Mr. Karl Kircher, Soldotna Middle School teacher, asked the Board how the elimination of agency fees advances the mission statement.

Dr. Atwater reported that on February 10 and 11, Alaska Shield will conduct a statewide emergency planning exercise which will simulate an area wide water shortage. He stated that as part of the drill, evacuees will be housed at Soldotna Middle School and pets will be cared for in a tent in the school parking lot. He reported that the Alaska Department of Homeland Security and the Office of Emergency Management has requested that the Borough assess the generators to be installed or replaced at Homer Middle School, Moose Pass School, Tustumena Elementary School, and Susan B. English School. He added that should grant money be available, the Borough will replace those specific generators. He announced that the hiring process has begun to replace Mr. VanDerWege, Tustumena Elementary School principal. He invited those present to attend the mass choir event at Kenai Central High, February 7 at 6:00 p.m.
