APPROVAL OF AGENDA:

The agenda was approved with the removal of Number 10b. Revisions to AR420 School Based Management/Site Council.

APPROVAL OF MINUTES:

The School Board Minutes of April 1, 2013, were approved as corrected. The School Board Minutes of April 9, 2013, were approved as printed.

SCHOOL REPORTS:

Mr. Trevan Walker, Seward High School principal, noted the stage set built by Seward High School student, Mr. Ben Miranda, for the drama class production of *A Funny Thing Happened on the Way to the Coliseum*. Mr. Walker gave a computer presentation that highlighted Seward High's transition into a Hybrid High School whereby technology, distance education, goals for instruction, capital project improvements (including one that would create a mezzanine study area for students), and career guidance liaison development, combined with course offerings in a traditional school schedule, would increase their ability to individualize the educational experience for every student.

Mr. Jason Bickling, Seward Middle School principal, presented a PowerPoint presentation that began with a yearbook cover contest entry designed by a student. He discussed the school's staff, goals, rules and expectations, the importance of "inquiry," various programs offered, developing student character, the student of the month program and criteria, teachers nominated (and one chosen) as BP Teachers of Excellence, community service projects (including school clean-up and sending packages to military personnel serving overseas), teamwork, and extra-curricular activities/sports accomplishments and awards. Seward Middle School Debate Team members, Mr. Alden Hamilton, Miss Kaylee Brockman, Miss Creeanna Whitcome, Mr. Joel Williams, and Miss Ayla Lapinskas, discussed the program, its successes, and the personal benefits of participating.

PUBLIC PRESENTATIONS:

Mrs. Erin Knotek spoke against the recently proposed Kenai Peninsula School Activities Association (KPSAA) regulation requiring all District schools to participate in the Borough Meets for cross-country running, cross-country skiing, and track and field.

Mr. Mark Fraad, Seward Elementary P.E. teacher, Region III National Education Association (NEA) director, and Kenai Peninsula Education Association (KPEA) executive board member, spoke against the proposal to move Seward 6th grade students to the middle school, expressed dissatisfaction over the District's procedures regarding the reconfiguration and the effects on the community, and encouraged the Board to select a third party to mediate the process and the decision.

Mr. Steve Keifer, Kenai Peninsula Youth Facility superintendent, thanked the Board for the services provided to Marathon School, expressed appreciation for Ms. Beth Swaby, Marathon School teacher, and requested that the Board allow Ms. Swaby to remain as the teacher at Marathon School. He presented the Board with a letter from Ms. Allison Gottesman, district supervisor, requesting that the Board allow Ms. Swaby to remain at Marathon School.

PUBLIC PRESENTATIONS:*(Continued)*

Ms. Maya Moriarty spoke in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school, and expressed appreciation for the work of school and District administration during the process.

Mrs. Terri Tidwell, Skyview High School head custodian, noted that May 6-10, is Staff Appreciation Week, read the names of District support staff that were retiring or had retired this school year including their years of services, and expressed appreciation for their dedication and hard work.

Miss Josephine Braun, Seward High School student, spoke against the recently proposed Kenai Peninsula School Activities Association (KPSAA) regulation requiring all District schools to participate in the Borough Meets for cross-country running, cross-country skiing, and track and field.

Ms. Katy Journey Scrivo, Moose Pass teacher, thanked Dr. Atwater for providing additional funding to Moose Pass School and expressed appreciation for the continuing work of Mr. Jason Bickling, principal.

Mrs. Sarah Spanos stated that she is undecided on the issue of moving Seward 6th grade students to the middle school. She discussed the possibility of adding an observation area for the Seward pool, similar to the one at Kenai Central High School.

Mrs. Celeste Lemme, parent, spoke in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school and the importance of middle school electives.

Mrs. Stephanie Mullaly, parent and ELL tutor, spoke in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school.

Mrs. Peggy Hamner expressed appreciation for Mr. Jason Bickling, Mr. Trevan Walker and Mr. Dave Kingsland (principals of Seward schools) and spoke in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school.

Mr. Dave Hamner discussed the Seward High School and Seward Middle School presentations, the collaboration of the two school programs, and spoke in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school.

Ms. Mica VanBuskirk spoke regarding the importance of music (including band) in middle school and in support of the reconfiguration of Seward schools to move the 6th grade students to the middle school.

Mrs. Julie Lindquist spoke regarding proposed KPSAA regulation changes, the need for improved attitudes toward students that do not attend borough competitions, the lack of participation by other District schools invited to Seward hosted sporting events, and requested that the KPSAA Executive Board member composition be revised.

At 8:40 p.m., the Board reconvened in regular session.

HEARING OF DELEGATIONS:

Mr. Matt Gray, Watershed Forum Program Coordinator for the Resurrection Bay area and overseer of the Seward School Yard Habitat Program, explained the program, its purpose, costs, and the integrating of student academics into the program. He stated that the program is designed to span two years, and described various projects including replacing non-native plants with native plants in school areas, and available local trail system design and maintenance.

**COMMUNICATIONS AND
PETITIONS:**

Dr. Atwater announced that Greatland Adventure Academy Charter School will delay opening for one year due to the inability to secure an adequate building. He stated that the merger of Soldotna High and Skyview High Schools will be effective August 2014 and District administration will present a recommendation for reconfiguring Soldotna grades 7-9 at the June Board meeting. He reported that the District will transfer \$268,000 to the Kenai Peninsula Borough Capital Projects Fund in order to upgrade classroom door locks, replace carpeting at the district office, and to pay for the design and development of capital improvement projects (which will help CIP applications to the state receive higher scoring). He noted that the annual Leadership Academy will be held on May 29 – 30, at Soldotna Middle School, beginning at 9:00 a.m. (which involves principals and one or two teachers from each site), discussed the agenda, stated that Dr. Susan McCauley from the Department of Education and Early Development (DEED) will be the opening speaker, and invited the Board to attend.

She thanked Mrs. Tidwell for acknowledging the number of years of service represented by this year's support staff retirees. She announced that this is her last school board meeting as KPESA president (the incoming president is Mrs. Patty Sirois).

Mrs. LaDawn Druce, KPEA president, expressed appreciation for the non-tenured teacher contracts to be approved on the consent agenda. She stated that she will attend the Borough Assembly meeting on May 7, to speak regarding the District's budget. She reported that on April 25, she attended the District's Effective Instruction Committee meeting and discussed the success of the committee. On April 26, she attended the state Advisory Committee meeting with Dr. Atwater and Mr. Peterson regarding the teacher evaluation process. She announced that May 7, is National Teacher Appreciation Day, thanked Seward and all district teachers for their work, and shared a quote from John Steinbeck. She noted that Mr. Mike Druce is completing his 41st year of teaching and is retiring after 20 years with the District, and congratulated all retiring teachers. She announced that this is her last school board meeting as KPEA president; that she will be returning to school counseling; expressed appreciation for the opportunity to serve as the KPEA president; and thanked the Board for their service. She announced that the incoming president is Mr. Neil Denny.

Mr. Al McCarty, president of Seward PTSA (recently changed to PTA), spoke regarding the Seward PTSA program and their recent decrease in membership, discussed a recent land trust law suit filed by the Seward PTSA, and thanked the Board for coming to Seward.

Ms. Mica VanBuskirk, Seward Site Council president, discussed the site council's recent actions regarding the reconfiguration of Seward schools to move the 6th grade students to the middle school, studies regarding reconfiguration, and transition tips. She responded to Mr. Tropp's statements regarding the effects of the reconfiguration on the community.

**SUPERINTENDENT'S
REPORT:**

Dr. Atwater reported that the District has finalized a seven year contract with Alaska Communications Systems (ACS) to provide improved internet connectivity to Nanwalek and Port Graham schools. He announced that there were no exceptions noted during the recent review of District Title programs and thanked Ms. Sandy Miller for her efforts in preparing for the review. He reported that District nurses were chosen to develop a streamlined standard and procedure for Alaska's school districts to follow with regard to collecting body mass index (BMI) data, and thanked Ms. Naomi Walsworth and the District nurses for continuing to be leaders in Alaska. He stated that Mr. Sean Dusek, Ms. Pegge Erkeneff, and he met with American Productivity and Quality Center (APQC) representatives last week and chose the top four District priorities for improvement: aligning technology and instructional departments; refining processes to reduce workers compensation claims; creating a process to provide better overall governance of process management; and reviewing and, as needed, refining the budget review and revision process. He noted that May 6 – 10, is Staff Appreciation Week and thanked all District staff for their work and contributions. He thanked the Seward schools and community for their attendance and expressed appreciation for the evening's testimony.

Mr. Jones presented the District financial report for the period ending March 31, 2013.

Mr. Jones reported on budget transfers Numbers 588 through 1010 for various schools and departments within the District.

Committee members testified and advocated for District priorities throughout the session. The committee will meet tomorrow, (May 7) and monthly throughout the year. She reported that she attended the Homer Legislative Town Hall Meeting, attended by Senator Peter Micciche, on Friday, May 3; a presentation to Homer High School's leadership class; the BP Teachers of Excellence Awards; and the Homer High School and Homer Middle School principal interviews.

Mr. Holt reported that he attended the final Career and Technical Education Committee meeting of year (where they selected three scholarship recipients), and the National School Board Association (NSBA) National Conference in San Diego, CA and discussed the speakers and seminars he attended while there.

Mrs. Crawford reported that she attended the Social Studies Curriculum meeting, announced that the current curriculum will be revised, stated that the committee will meet this summer, and community input will be considered. She also attended the BP Teachers of Excellence Awards.

Mrs. Vadla reported that she attended the BP Teachers of Excellence Awards, the National School Board Association National Conference in San Diego, CA and discussed the speakers and seminars she attended while there, she visited Moose Pass and Seward schools before the meeting today, and expressed appreciation for the strength and involvement of the Seward community.

Mrs. Hilts reported that she attended the National School Board Association National Conference in San Diego, CA and discussed the speakers and seminars she attended while there. She stated that during the day's board policy committee meeting, among other items, the committee discussed the use of personal electronic devices in classrooms.
