Mr. Dusek announced that this week we celebrate Teacher Appreciation Week, Student Nutrition Services Appreciation Week and Nurse Appreciation Day (May 6). He reminded the Board to thank these staff groups for their work. He stated that the Board will hold an all-day work session on June 2 at the Soldotna High

School library.

ADVISORY COMMITTEE, SITE COUNCIL AND/OR P.T.A., K.P.A.A., K.P.E.A., K.P.E.S.A, BOROUGH ASSEMBLY: Mrs. Patty Sirois, K.P.E.S.A. president, thanked Aurora Borealis Charter School for their presentation. She congratulated Mr. David Kalugin on his Golden Apple Award. She expressed her condolences to the Susan B. English School employee whose husband recently passed away. She congratulated Ms. Sandra Geagel on her retirement. She noted the importance of swim clubs and school pools. She commented on the first reading of BP 5141.21 Administering Medication and stated that school secretaries administer medications in a school nurse absence and requested that certified staff be assigned to perform these duties instead. She thanked teachers and student nutrition employees in recognition of their appreciation week.

Mr. David Brighton, KPEA president, thanked the Board for their recent and ongoing work with legislature. Earlier in the day, she toured the Seward AVTEC building with Mr. Ben Eveland and expressed appreciation for the programs offered there. She stated that she had missed a couple of meetings recently due to illness.
