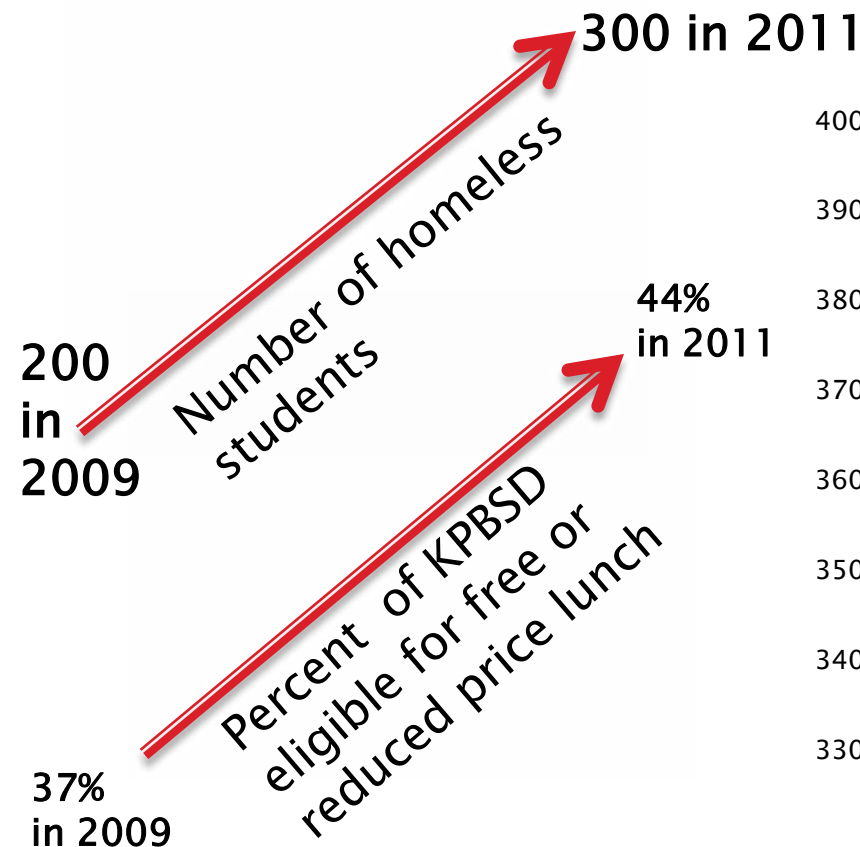
# *Celebrating our School Year*

- 580 students earned diplomas  
(47 from alternative high schools)
  - Student scores on state tests improved and continue to be well above state averages
  - New evaluation systems for teachers and principals will be in effect in August– this will lead to better instruction and increases in student learning
  - Community support for schools as measured through volunteers and fund raising continues to be strong

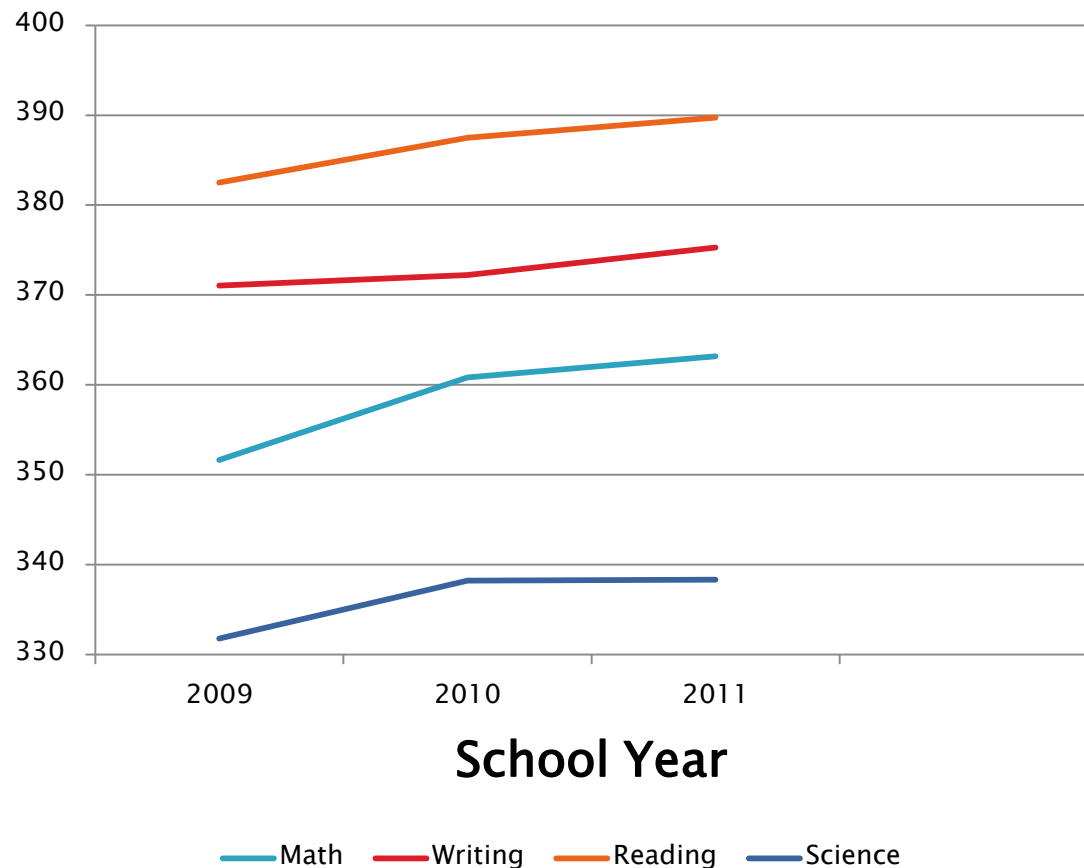
# FY11 Enrollment Trend

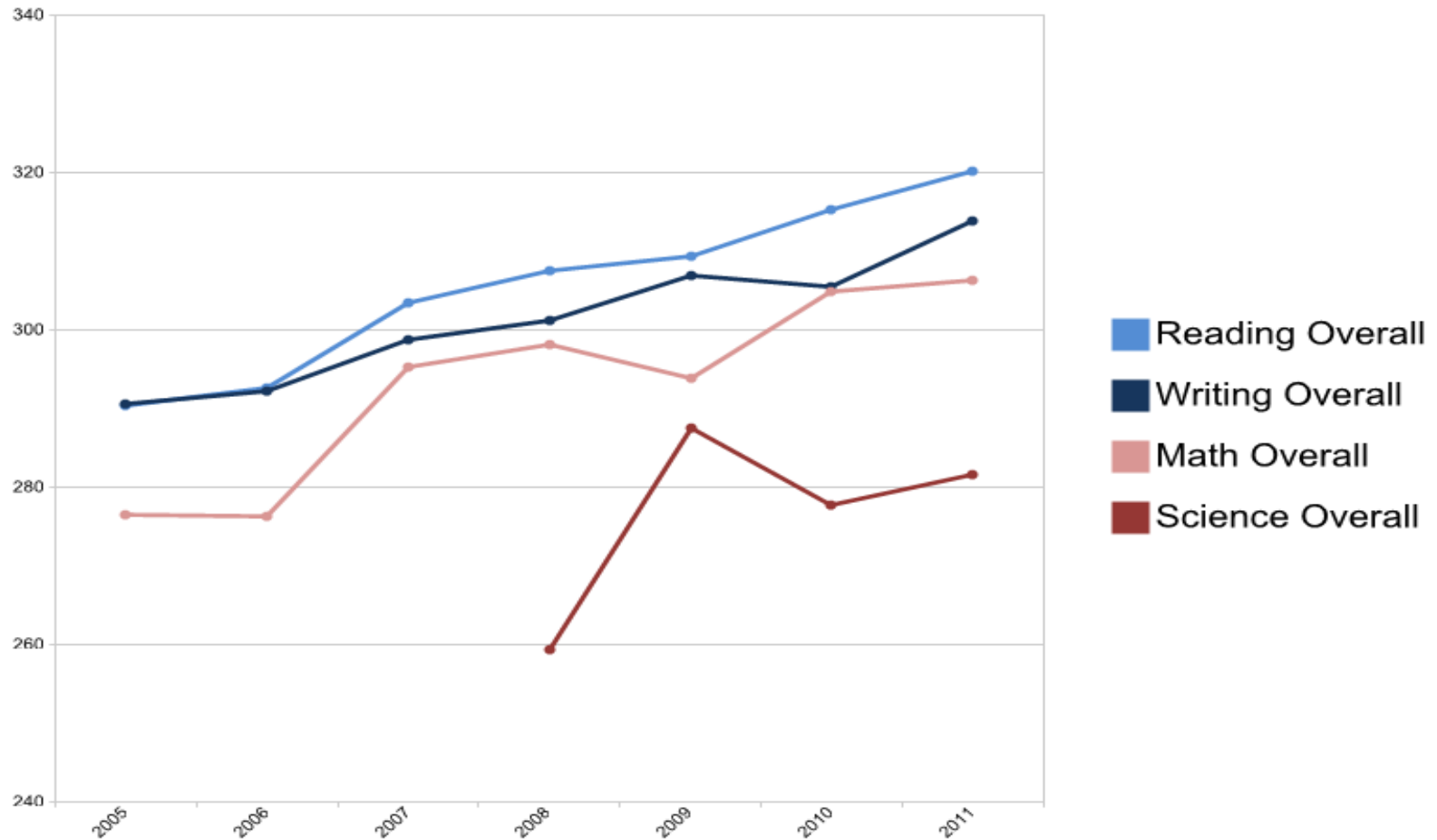


Grades 3–10 SBA Averages 2009 – 2011



# Economic Significance of KPBSD– study done by ISER

- Through direct jobs and payroll, the district creates an additional 880 jobs
  - In another sense, There is \$33,710,222 in payroll generated by the employment and spending of the district on top of the \$64,154,347 of direct wages paid by the school district
  - The extra payroll represents \$33.7 million dollars that would not be circulating within the economy without the school district.
  - for every one dollar of district payroll, 30 additional cents are created through indirect and induced economic activity.

# Looking to August, where are we with funding for FY12

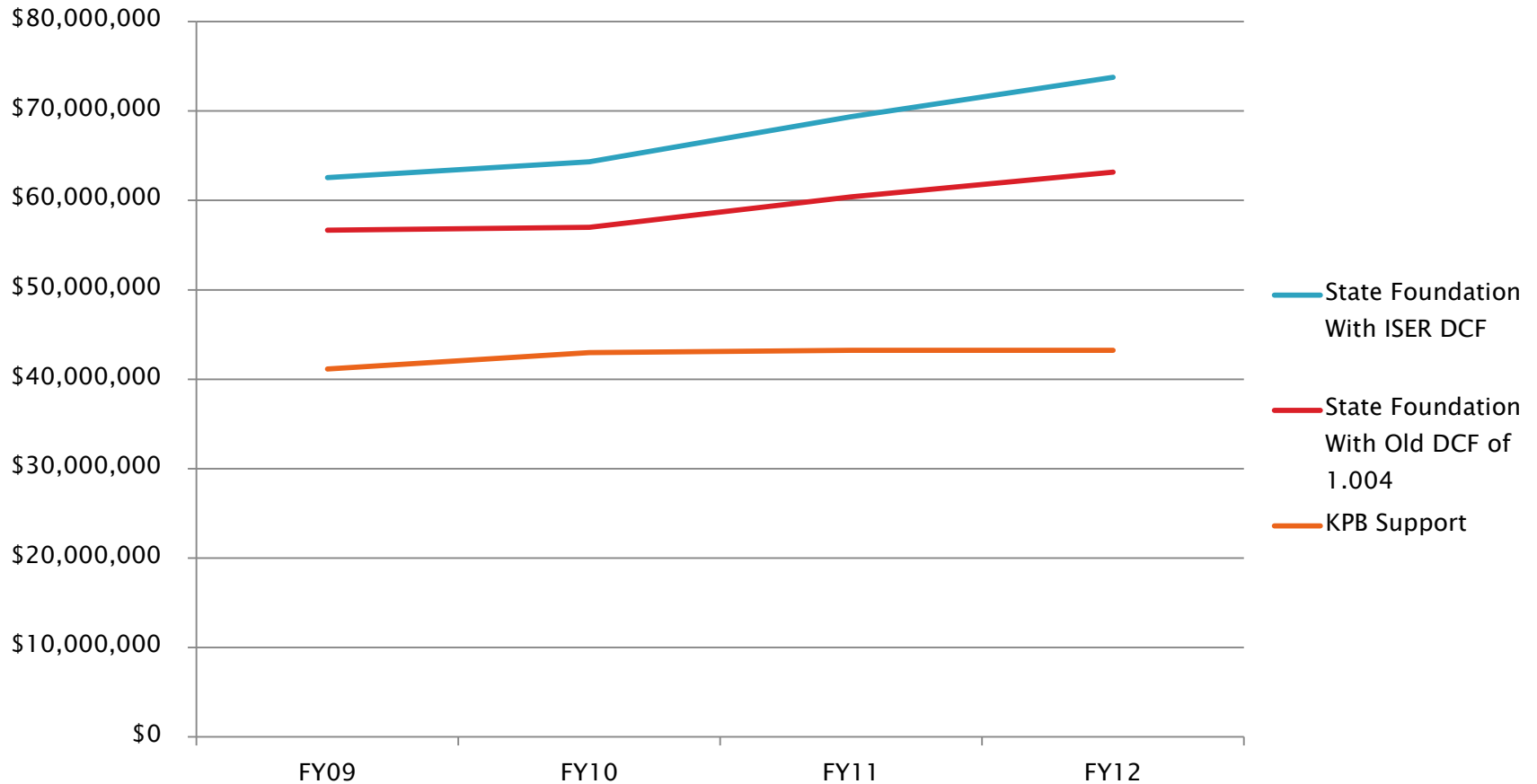
- ▶ State added \$1,440,575 million (one-time money)
  - ▶ State added \$831,389 (for five years) for Career Technical Education
  - ▶ Transportation contract extended by one year and is \$733,056 more than last year
  - ▶ We are budgeting to spend \$2,119,455 of our fund balance for next year

# Update on Equipment Fund

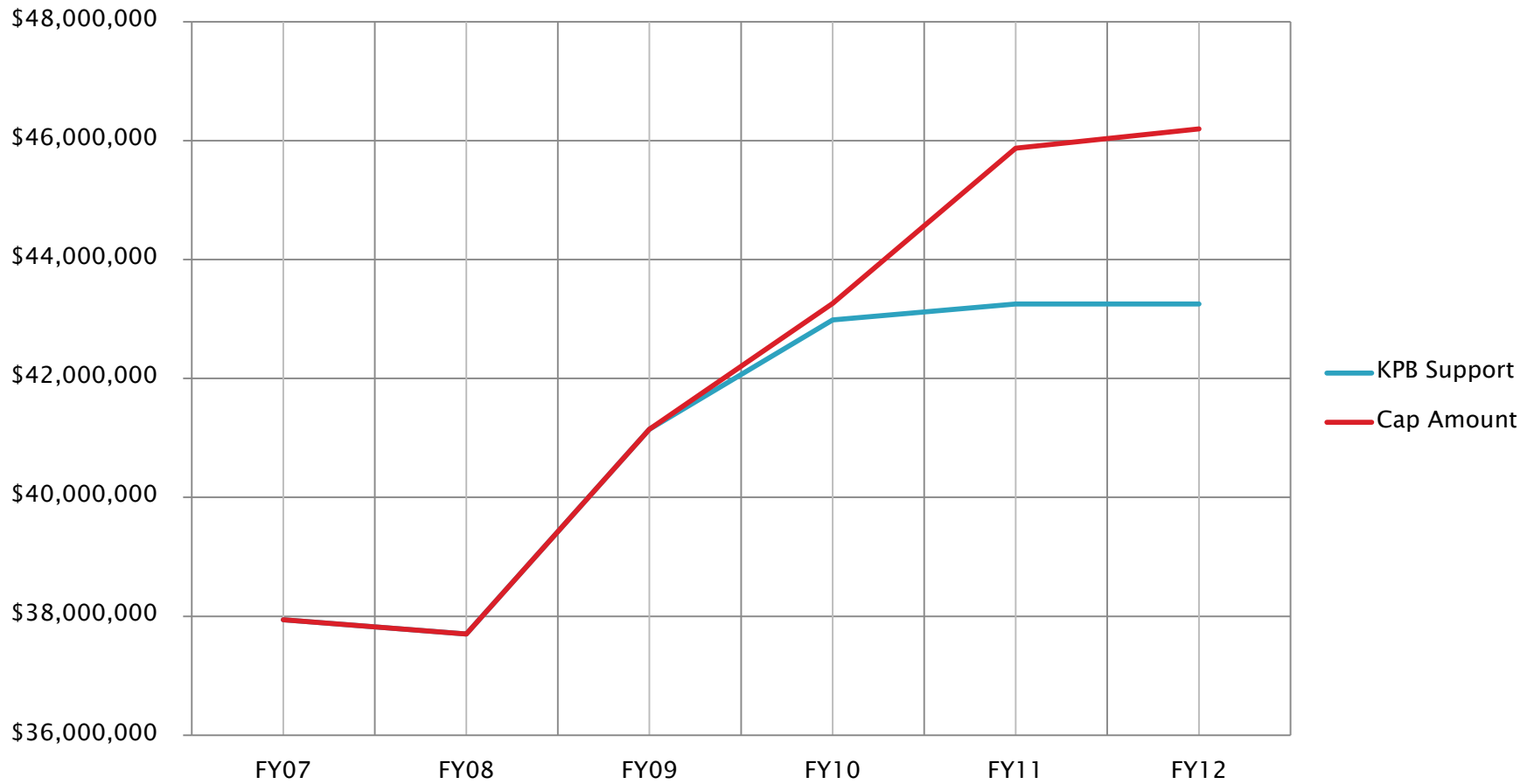
▶ July 1, 2010 balance	\$6,676,615


